1.(Clause. NO.12 REDELIVERY):- AS AMENDED

THE VESSEL SHALL BE REDELIVERED AT ANY PORT /HARBOUR WITHIN THE MALACCA STRAIT-BAY OF BENGAL RANGE (OWNER'S OPTION) IN LIKE GOOD ORDER AND CONDITION, ORDINARY WEAR AND TEAR EXCEPTED. PRIOR TO THE ARRIVAL OF THE VESSEL AT THE REDELIVERY PORT OR PLACE, THE CHARTERERS SHALL SERVE THE OWNERS NOT LESS THAN 30 (THIRTY) DAYS NOTICE OF THE VESSEL'S EXPECTED DATE AND PROBABLE PORT OF REDELIVERY AND THEN 15/10/7/5/3/2/1 DAYS DEFINITE NOTICE OF REDELIVERY. FOLLOWING THE TENDER OF ANY SUCH NOTICES THE CHARTERERS SHALL GIVE OR ALLOW TO BE GIVEN TO THE VESSEL ONLY SUCH FURTHER EMPLOYMENT ORDERS, IF ANY, AS ARE REASONABLY EXPECTED WHEN GIVEN TO ALLOW REDELIVERY TO OCCUR ON OR BEFORE THE DATE NOTIFIED. ACCEPTANCE OF REDELIVERY OF THE VESSEL BY THE OWNERS SHALL NOT PREJUDICE THEIR RIGHTS AGAINST THE CHARTERERS UNDER THIS CHARTER PARTY.

PRIOR TO THE ARRIVAL OF THE VESSEL AT THE REDELIVERY PORT OR PLACE, THE CHARTERERS SHALL SERVE THE OWNERS NOT LESS THAN 30 (THIRTY) DAYS NOTICE OF THE VESSEL'S EXPECTED DATE AND PROBABLE PORT OF REDELIVERY AND THEN 15/10/7/5/3/2/1 DAYS DEFINITE NOTICE OF REDELIVERY. FOLLOWING THE TENDER OF ANY SUCH NOTICES THE CHARTERERS SHALL GIVE OR ALLOW TO BE GIVEN TO THE VESSEL ONLY SUCH FURTHER EMPLOYMENT ORDERS, IF ANY, AS ARE REASONABLY EXPECTED WHEN GIVEN TO ALLOW REDELIVERY TO OCCUR ON OR

BEFORE THE DATE NOTIFIED. ACCEPTANCE OF REDELIVERY OF THE VESSEL BY THE OWNERS SHALL NOT PREJUDICE THEIR

RIGHTS AGAINST THE CHARTERERS UNDER THIS CHARTER PARTY.
