2. PARA.NO. 10. DELIVERY:

THE VESSEL SHALL BE PLACED AT THE DISPOSAL OF THE CHARTERERS AT EX-YARD (JIANGSU NEW YANGZI SHIPBUILDING CO. LTD, JIANGSU (NEAR SHANGHAI), CHINA) ATDNSSHINC. THE VESSEL ON HER DELIVERY SHALL BE READY TO RECEIVE CARGO WITH CLEAN SWEEPED HOLDS AND TIGHT, STAUNCH, STRONG AND IN EVERY WAY FITTED FOR ORDINARY CARGO SERVICE, HAVING WATER BALLAST AND WITH SUFFICIENT POWER TO OPERATE ALL CARGO HANDLING GEAR SIMULTANEOUSLY.
