Subject: Government Approval to Participate in MSc Program at World Maritime University in Malmo, Sweden.

This is to inform you that the competent authority of Bangladesh Shipping Corporation (BSC) has approved your participation of 14 months MSc Programme in Maritime Affairs Programme. He will be Specialized in "Shipping Management & Logistics" at World Maritime University in Malmo, Sweden. The programme/ course is a full funded scholarship by The Sasakawa Peace Foundation. He will be allowed to stay in Malmo, Sweden for the course from 13-09-2021 to 30-10-2022 (excluding travel and transit time) under following terms and conditions:

Terms and Conditions:

- a. The whole period of programme/course will be treated as on duty.
- b. Salary & allowances of said period will be paid in local currency by Bangladesh Shipping Corporation, not allowed to receive any part of salary/allowances in foreign currency.
- One way air ticket fair (Dhaka-Malmo) will be borne by Bangladesh Shipping Corporation.
- d. All expenses of MSc programme will be borne by WMU/ The Sasakawa Peace Foundation.
- e. After reaching at Malmo, you will inform and register to Bangladesh Embassy in Sweden and inform the same to Bangladesh Shipping Corporation authority within 14 days.
- f. You will not be allowed to stay beyond the permitted period. After completing the said course you will have to join Bangladesh Shipping Corporation and serve at least 5 years continuously as stated in bond, otherwise you or your nominee bound to pay Bangladesh Shipping Corporation Tk.25,00,000.00 (Taka twenty five lacs) only.
- g. After returning from WMU, you have to submit course report within 7 days.
